School has it). Yet year after year the tution fees of the students are raised on the plea that price at everything else has gone up except the guardians/parents salary.

By letter no SH 4/16-20/88 of 25-1-89 of the Education Ministry the English medium. tutorials here advised not to increase their tulion fees. They have however managed to put pressure on the Education Ministry and forced them to change their decision by alongwith them to increase their fees by 30 percent. This is so because most of these tutorials are run by people who have connection with the top notch and can sway the decisions in their favour.

Did the ministry really examine the income and expenditure accounts of these

situated at as an instance. According to details submitted by the school to the Education Ministry they had 584 students on their rools in 1988. The tution fee-from these students came to Tk 33 lakh. The yearly changes came to Tk. 6,97,200 although it has been omitted from the income side of the schools' student form, The total annual income for last year therefore was Tk 40,03,200/- whereas the total expenditure shown in Paras 9-10-11 of the same form amounts to Tk 28,64,488 only. The annual net profit was Tk 11,38,712. With this huge amount was there any need to enhance tuition fees? After enhancement of fees have students been provided with additional facilities (the plea for enhancement)? Moreover insiders allege that the house Scholastica is not the lone school which has inreeased tuition fees. Naila Memorial Fleur Tutorial has doubled its previous years tuition fees forcing many guardians to change school.

It is time that things should be investigated. The govt should deeply look through the accounts of these schools check and verify then in the context of the socio-economic pattern of the country and do the needful to stop such unjustified fee hike. Above all govt decisions shouldnot be changed every now and then. This creates a lot of pressure. It is justified for a parent who paid the Tk 350 in June 87 for a KG students to pay Tk 700 now for the same class?
