Excessive fee being realised from SSC examinees

fees are being realised from students for the ensuing Secondary School Certificate (SSC) Examinations under Jessore Board by all high school authorities in Jhenidah town... it is alleged.

It is alleged that violating the board's instruction the school authorities were realising excessive fees than the actual rate fixed by the Jessore Education Board for this year.

An examinee is required to pay Taka 294, for Humanities Group including practical fee for typing and Taka 326 for Science Group including practical fees.

But the school authorities realised Taka 1000 from an examinee. Some schools of the town realised Taka 961 from every examinee of both the Humanities and Science groups, Taka 842 to Taka 900, Taka 815 to Taka 847, Taka 840, to Taka 870, Taka 791 to Taka 823, Taka 620 to Taka 670, Taka 862 to Taka 900 and Taka 509 to Taka 555 respectively.

It is curious to note that there is no uniformity in the realisation of examination fees in these schools. The local government Boys High School and Government Girls High School realised examination fees as per board's direction, it is learnt.
