

Dismissal of concerned teachers suggested

SSC, HSC exam. results of UNO. sons cancelled for cheating

JESSORE, May 16:—The results of two brothers securing first place in the S.S.C. examinations and 10th position in the H.S.C. examinations, 1988 of Jessore Education Board were cancelled in a meeting of the top officers of Board on May 5. The two brothers, Kazi Shafiul Nasir and Kazi Nafiul Mazid have been bared from appearing at the examination in 1989-90 session.

The committee of the top officers also recommended criminal suits against the persons who were directly involved in the malpractices. The decision was taken after an assessment of the report submitted by the inquiry committee.

The assessment of the inquiry report revealed that the S.S.C. examinee of Babugonj centre in Barisal Kazi Shafiul Nasir and the H.S.C. candidate of Rakudia College centre under Babugonj Upazila adopted unfaremeans in this respective examinations in 1988. They were directly assisted in the malpractices by their father Kazi Lookman Hossain, the then upazila Nirbahi Officer of Babugonj Upazila.

The report said, Kazi Shafiul Nasir, a student of St. Josef School, Khulna bearing Roll-Khulna No. 159 and his brother Kazi Nafiul Mazid, a ... student of Daulatpur Govt. B.L. College bearing Roll-Daulatpur No.

2 had applied to the Board authorities for the change of centres as a part of their previous plan of adopting unfairmeans in their respective examinations. As per their appeals their examination centres were changed to Babugonj and Rakudia College centre under the same upazila respectively. The father of the examinees created opportunities for

his sons to adopt dishonesty in the examinations by exercising his powers illegally.

The inquiry teams also observed that Kazi Shafiul Nazir wrote the answer scripts of english first and second papers, science second paper, Islamiat and Bengali first and second papers slowly sitting either outside the centre or at home. They also adopted ofher malpracties in the answer scripts.

Kazi Nafiul Mazid, on the other hand submitted all his answer-scripts after writing them from outside the examination centre. The serial number of the scripts testified it.

The charges of wide-spread unfairmeans against both the brothers were provide beyond doubt and the committee of Jessore, Education Board took the decision.

Besides, the matter, being a grave * irregularity and based on malpractices and the charges proved against them and teacher of Babugonj Pilot School Md. Ishaque and the Vice-Principal of Rakudia College Abdul Mannan and Assistant Professor in the Department of Chemisty Ishaque Sharif, the committee recommended holding up their salary and grants and their dismisal.

The H.S.C. centre at Rakudia College was cancelled. The Chairman of the Board reported that such incident was the first in the country.
