It is gathered from informed sources that the director, of Institute of Business Administration (IBA) may again try for opening the BBA course from this session. The forms have been printed and are awaiting to be officially sold although the official permission to open this course has not been granted to it.


The IBA was set up as a post graduate school as par the Fourth Statute of the DU and there is simply no scope for opening graduate courses. here. If statutory changes are to be made they should be done by the Governing Body but no such permission was been granted so far. The main reason behind this is the existence of the Commerce Faculty having the departments of Finance, Marketing, Management and Public Administration here.

It may not be out of place to state that in countries abroad the Institute of Business Administration and the Faculty of Commerce never coexist in the same university. But here at DU, unfortunately the bulk of the money is being diverged to the IBA while the other four departments under the Faculty of Commerce have remained extremely neglected since the opening of this institute because the general public seem to hold the IBA students in greater esteem.

However inspite of not getting the green signal from the University Grants Commission or from the Governing Body, the present director of the IBA started selling BBA forms last year. Five thousand forms were sold for fifty taka each amounting to taka five lakhs along with some five hundred guides for forty takas each amounting to Tk two lakhs.

Even the date of the examination was announced until the Vice Chancellor, Prof Mannan woke from his slums ber and stopped the sale of forms through an office order. How could the director play with the fate of five thousand students? What gave him the strength to go ahead with his sinister plans and why didnot

Inspite the VC's order the director of IBA has till date not refunded the five lakh takas to the students. However last year he was justifying the

their hands in that direction.

As reported earlier the director of IBA might again try to open BBA course this year too but the departments under the Commerce Faculty are dead against this move and on the contrary feel that the IBA should be brought under the faculty and not allowed to operate as a separate institute.

They say the money that is spedt at the IBA would if diverted to the other departments help to benefit a greater number of students. They also opine that the computer section of this institute and their library should be open for all ytudents of the Commerce Faculty of DU and not, only for the IBA students.

The IBA teachers however opined that the teachers of the commerce faculty are

apprehensive of the fact the if BBA course is introduct at the IBA all good students will come there instead of going to the commerce faculty. The teachers feel that the very existence of these departments will be at stake so the teachers are creating problems to open the BBA course.

Things are not all right at the IBA however. Runnelies run that it is a den of corresption. The director of IBA it is gathered has illegally errated four posts of programme directors and six departmental chairmens in the institute. He has also formed a Doctoral Programme Committee by the lone professor of the last tute is not a member of this frommittee.

Forms priced at Tk 10 for MBA entrants are sold for Tk 100 each. Moreover there is a rule at the IBA the entrants desirous of joining in institute are entitled to two months free coaching in English and maths but here they are forced to pay take five each whether they like it or not.

Without tender hostel furniture for three lake takas have been purchased along with buying a now conditioned car for the institute.

is an acute shortage of books, deplorable condition of hostel and appalling food firved at the dining halls, the director of IBA moves around in the most expensive car which is even costlier than the VCs. He has also appended a number of his own people or like minded people in the department and he be today IBA is a company of the director.
