# DU teachers demand inquiry All S.M. Hall house tutors resign over Arif murder

All the eight house tutors of Salimullah Hall of Dhaka University resigned en masse yesterday demanding security to the lives of students of the university and protesting misbehavior with them by some unruly students following killing of Arif Ahmed, a student of the hall.

The resignation of the house tutors followed that of Prof KM Mohsin, the provost of the hall, on Thursday. Till writing of this report, the resignation of the provost and the house tutors was not accepted by the Vice-Chancellor of the university.

It was learnt that Vice-Chancellor Prof Abdul Mannan yesterday requested Prof Mohsin to withdraw his resignation. But he was still firm to his decision. Prof Mohsin was a candidate in the December 7 Syndicate election from the provosts' quota.

Commenting on the resignation by the house tutors a teacher of the university said, the resignation should be considered as a protest against the administrative failure to maintain moral authority on

the university affairs. When the university loses its moral authority, then nothing is left for the institution to function, he added.

### JANAZA OF ARIF

Meanwhile, Separate gayebana janaza of Arif Ahmed, a final-year-student of the Finance Department of the university was held at the University Central Mosque after Jum'ia prayer and in Salimullah Hall premises. Arif was resident of the Hall.

Arif was shot at on Wednesday night while attending a rally of all-party students combine in the S.M Hall premises and succumbed to his

were frequently moving in the campus and threatening the workers of different students organisations, it added.

The statement condemned the university administration and law enforcing agencies for not taking any action against them. The student organisations that issued the statement included Jatiyatabadi Chhatra Dal, Chhatra League (N-S), Bangladesh Chhatra Moitree, Chhatra League (S-S), Godotantik Chhatra Union, Bangladesh Chhatra Kendra, Biplobi Chhatra Dhara, Chhatra Oikya Forum, Samajbaei Chhatra Jote, Gontantik Chhatra League, Biplobi Chhatra Union (Abu), Chhatra League (I-A) Chhatra League (Mamun), Chhatra Federation and Samajtantrik Chhatra Front.

Thirteen vice-presidents and general secretaries of different hall students unions of the university also issued another joint statement condemning the killing and accusing Chhatra League (H-A) for the incident. The statement demanded expulsion of the terrorists from the university.
