

## Education and Corruption: Its Means and Ends

The pharmaceutical companies in have been employed under-qualified employees, but lose ten times more through inefficiency and wastage. However, education is not a business, not taking arms to control the universides residential halls, not a heaven for the couples, it is the process of acquiring the values, the knowledge and developing the atti-tudes, skills, and behaviors to live in concordance with one-self, with others, and with the natural environment. Now a day's education is a business if you have money you will have certificate. Those certificates create a cancer in the society because neither have got a job nor go to the field to help the farmers. This is the main problcm worldwide but in Bangladesh, the situation is completely different. The stu-dents go to the university where no competitive examination is required to justify the ability of the students, their university life is colorful, universities for pleasure not panic, after passing colorful life in universities they easily get the jobs, in that case universities help students through internship and parents by power. If all students have masters, PhD certificates, the real certificates holder will under pressure by the half knowledge students.

BCS examination recruits the candidate only on the basis of general knowledge. Imperfect or incomplete knowledge seems to be inevitable by the

necessity of circumstances. It is proved that half-knowledge is dangerous, the question is: how can we counteract or ininimize this danger? The answer is to arrange quality education for a qualified man to set up that position where he suitable for fit.

The students

The students who are obtained the position first class first in respective subject at university, is generally eligible for acculty position in their departments. As a result, the first class first will get the job at the university but remaining students leave the campus as qualified person in respective subject.
