SITTING ALLOWANCE FOR DU VC, PRO-VC

Provision degrading for univ: teachers

CURRENT and former senior teachers of Dhaka University think that provision of allowances for attending meetings for statutory positions like vice-chancellor and pro-vice-chancellor of the university dents the image of the country's highest seat of learning.

The VC and pro-VC should be kept out of the purview of the sitting allowance as taking part in different committee meetings or presiding over them is their statutory responsibility, they say.

Continued from page 1 one, already entitled to various facilities like residence, full time car, office bearers and others.

The issue hecame a talk among the university teachers as the authorities circulated that DU incumbent VC Professor AAMS Arefin Siddique did not receive any of the sitting allowances worth Tk 1.25 crore in last seven years.

They have found the university authorities to have been trying to 'highlight' Arefin at the cost of other teachers' 'dignity'.

A quarter of the teachers also raised their eyebrows over the amount of sitting allowance of DU as they said that the amount a VC could draw from sitting allowance in a month was more than the VC's monthly salary.

When approached, Dhaka University vice-chancellor AAMS Arefin Siddique refused to make any comments on the allowance issue.

The university treasurer, Professor Kamal Uddin, also did not want to comment on teachers' demand that VC and pro-VC, should be kept out of purview of sitting allowance.

Kamal Uddin said he, while presenting this year's university budget in the annual senate meeting on June 16, had said, 'Pro-vice-chancellor, treasurer and others, who hold the higher

positions in the university, received, sitting allowances happily.

happily.'
But only our vice-chancellor has not taken any sitting allowances worth Tk 1.25 crore in the last seven years', he added.

He said that he had cited the example to demonstrate how much a person could sacrifice for the university.

When New Age sought information from Kamal-Uddin regarding when the sitting allowance system for all and the provision including VC and pro-VC for the benefit was introduced, he could not say exactly when but added that it was introduced several years back.

Kamal Uddin also failed to provide information about the amount of money received as sitting allowance and how many people so far received it. It is not possible to keep accounts of individual's sitting allowance,' he said.

Former DU treasurer and current VC of Jagannath University Professor Mijanur Rahman said that 'sitting allowance for teachers and externals was introduced in 2003. But the allowance was not applicable for VC and pro-VCs'.

Professor SMA Faiz, who

Professor SMA Faiz, who was VC of DU between 2002 and 2009, said that when the sitting allowance was introduced for others teachers, VC and pro-VC were left out of the benefit as VC and pro-

VCs are trying to get sitting allowance by presiding over meetings,' he added.

'Presiding over meetings is part of job responsibility for the VC,' he observed, elaborating that the position of VC was prestigious and dignified.

'We should not evaluate this position in monetary term,' he said.

Announcing that the VC has not taken sitting allowance is nothing but camouflage and created confusion among many,' he commented.

Samad also suggested that there should be transparency about how much money VC could spend in a year or month.

Both Mijanur and Samad

rere skeptical about the figre, Tk 1.25 crore, which the C was said not to have resived as sitting allowance.

Mijanur claimed that the gure was 'exaggerated'.

If he [Arefin] did not ke Tk 1.25 crore money in even years, it means he had of taken Tk 1.48 lakh per onth, which is more than a salary,' Mijanur pointed it.

SMA Faiz claimed that reulation of news that DU cumbent VC was the only ne who did not take sitting lowance hurt him as a forner VC.

'It hurts me as many startd asking me if I took sitting llowance,' he said.

'If the current university administration has changed the provision allowing sitting allowance for the VC and the pro-VC, it was an unwise decision,' SMA Faiz added.

Another former DU VC AK Azad Chowdhury fused to make any comments when New Age approached for his comments about significant allowance.
